

Spotlight on Faculty Member, Dr. Joseph LaMotta

What do you like most about medicine? In medicine you are empowered with the privilege of a profession like no other. There are certainly other professions that can be likened to medicine regarding being entrusted with the wellbeing and/or safety of a person or a group of people. But there is no other profession for which the outcome of your care and performance is directly dependent upon being endowed with the permission to physically examine and evaluate another person. In medicine the ultimate 'invasions' of privacy (physical and psychosocial) coupled with the recruitment of trust on the part of the patient are at the core of your responsibility toward literally improving or changing someone's day to day reality. It is very humbling and satisfying to be able to contribute toward making a difference in the day, the week, the month or the year(s) in the life of another person. And the irony is that this result is often accomplished, at least in part, just by conveying your concern and consideration before (or even despite) a physical resolution. Hence, the segue into one of the main reasons that I had chosen Ob/Gyn...it is the quintessential specialty with regard to providing life long, life-stages based continuity of care. One of my foundational tenets of patient care is that I would rather that a patient not believe me than not trust me.

What do you like least about medicine? I'm not sure that it is so much what I like the least as much as it that which has/have had a paradoxical impact upon the practice of medicine. For instance, electronic medical records. While they can be very important for algorithmically standardizing medicine and implementing "best practice" paradigms, it does impart a reflexivity, a dependency, a clinical repetition, a complacency and a consequent 'expectation' regarding management and outcome. One sequela of which has been some diminishment in the 'art' of medicine by creating clinical 'guard rails'. Granted, some of the more acute/resuscitative based clinical situations warrant such a linear management construct, but I feel as though the practice of medicine has become progressively more compartmentalized and, in some clinical scenarios, even "binary". Additionally, while EMR and best practice guidelines have been developed, and have become relied upon, to mitigate lapses in communication and gaps/oversights in clinical 'judgement', they have notably supplanted the original "EBM", or what I refer to as "experienced based medicine". I am not suggesting that best practice guidelines should be ignored, but I still believe that context matters, and that clinical experience/judgement should be complementary to practice guidelines when not to the predictable detriment of the patient. Clinical 'quard rails' should be made of rubber, not steel. The practice and delivery of medicine has in many respects become 'necessarily' institutionalized and compartmentalized, but which has also nearly eliminated the logistical and clinical individualization of the practice of medicine. Lastly, while the advent of EMR, practice guidelines and the institutionalization/compartmentalization of medicine have 'standardized' the delivery of medical care for both physicians and patients alike, they have not necessarily 'streamlined' it; and hence a paradoxical decrease in physician satisfaction as the result of the transition to a more "menu" based, redundant and less autonomous paradigm.

A few words to the residents: Suffice it to say that you will leave Cooper confident, reassured and knowing all that you need to know to be an extremely competent Obstetrician and/or Gynecologic Surgeon and to practice in the clinical environment or subspecialty of your choosing. At the risk of sounding, well...like me, always remember to be pragmatic and clinically curious. Do not abandon the age-old construct, fundamental skills and the art of clinical diagnosis; it has and always will begin with the HPI and end with labs and imaging, not the other way around. I was once told that "the more that you see the more you'll know, and the more that you know the more you'll see". Try not to be a specialist who happens to be a clinician, be a clinician who happens to be a specialist. If not already, you will soon realize just how privileged that you are to be doing/to have done your residency at Cooper.

My final thought...due to the inherent investments of time, logistics and conscience demanded by medicine, it is extremely easy for your career to define you. Try not to let it unless that is truly your intention. Cooper Ob/Gyn Residents are an exceptionally remarkable group of people who just happened to have chosen medicine as their career and that we, as attendings, are equally as privileged to be learning from you. Thank you for that.








Philadelphia Regional Educational Consortium of OBGYN (PRECOG),

a boot camp for new interns, was held on June 28, 2024, at the Virtua Simulation Center. 46 interns and 19 faculty from the OB/GYN programs from the surrounding region, including our own faculty, Drs. Hewlett, Adriance, Malik and Kim participated. The interns learned knot tying, how to perform cesarean deliveries, perineal repairs, laparoscopy, hysteroscopy, cervical ripening techniques and IUD placement.
